

Material impact of COVID-19 pandemic on operations and performance of the Company:

Due to nationwide lockdown , the Company's plant and registered office at Nagpur has suspended its operations effective 22nd March 2020 along with Company's Corporate office at Mumbai. The Company is following the Government directives regarding the health and safety of the workforce. The Company will continue its efforts towards achieving normalized level of operations, depending upon prevailing situation and the Government directives.

However, the impact of Covid-19 situation on the Company's business is not immediately ascertainable at this stage. Company is in process of evaluating the impact of COVID-19 pandemic on the business, performance and financials, both qualitatively and quantitatively .

The Company will continue to monitor the fast changing environment as it evolves and will inform the stock exchange about the impact shortly.
